



# Taking the stress out of compliance

# **How stressed are compliance teams?**

According to a **study** conducted by Corporate Compliance Insights in 2022, **51% of compliance officers surveyed have a lot or extreme jobrelated stress.** Not only are compliance teams stressed, but they also work extreme hours, with more than half of respondents reported working more than 50 hours a week.

With many things on the line compliance teams must be certain that they are successfully preventing, identifying, and mitigating compliance risks.

Any wrong step or number reported can put compliance teams at odds with management and cause severe consequences for their companies not only financially, but also reputation-wise. With this extra pressure added on compliance teams, it is clear that they are operating in very stressful environments.

When asked what the main cause of stress was, respondents were clear – there were just too many details to track and not enough resources or tools.

In a <u>survey conducted by Deloitte in 2020</u>, 55% of organizations say their compliance culture is based around a "Can we" rather than "Should we" attitude indicating a focus on building a more proactive and positive compliance culture.

In the same survey, respondents were clear that the general pace of changing regulations was at the top of the list of stress factors.

40% of respondents also noted that they lacked the support, respect, or resources they need to do their job effectively.




#### Wrapping it up:
